

## Official Rules for 2025-2026 BRINKS COMMERCIAL Sweepstakes

1. Eligibility: No purchase necessary to enter or win. Subject to all applicable federal, state and local laws and regulations. Void where prohibited. The **2025-2026 BRINKS COMMERCIAL Sweepstakes** (the “Promotion”) is open to legal residents of the United States and District of Columbia who are 18 years of age or older at the time of entry. Employees, including immediate family members and any persons living in the same household whether or not related, of Hampton Products International Corp. (“Sponsor”) are not eligible to participate. The winner will be notified by email and must respond to Sponsor and sign the Statement of Eligibility within 48 hours (the “Response Period”) to claim their prize. If the winner does not respond via email during the Response Period, an alternate winner will be randomly selected.

SUBMISSION OF AN ENTRY CONSTITUTES ENTRANT'S AGREEMENT TO THE TERMS AND CONDITIONS OF THESE OFFICIAL RULES.
8. **General Conditions:** Sponsor reserves the right, in its sole and absolute discretion, to cancel, amend or suspend this Promotion, or to amend these Official Rules, without prior notice, for any reason. Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor including, without limitation, government issued photo identification) to participate in this Promotion. In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Promotion-related materials, the terms and conditions of these Official Rules shall prevail, govern and control.
